

## Advertisement for Bid

Sealed bids will be received by the Board of Commissioners of the Rob Roy Drainage District No. 2 until **5:00 p.m. local time on October 9, 2012** for the **Reynolds East District Tile Rehabilitation Phase 1 Project**. Bids will be received at the offices of the Sugar Grove Township Assessor, at the Sugar Grove Township Hall, 54 Snow Street, Sugar Grove, Illinois, 60554. The bids will be read out loud prior to the Rob Roy Drainage District No. 2 regularly scheduled board meeting at 5:30 pm on Tuesday, October 9, 2012.

A pre-bid meeting for this project will be held on Wednesday, September 26, 2012 at the Sugar Grove Township Hall at 1:00 p.m.

The proposed improvement consists of the installation of twenty (20)-four foot diameter catch basins, with one foot sumps, on the existing Reynolds East branch of the District's tile system, located through agricultural fields north of Jericho Road and east of Illinois Route 47. Also included will be the replacement and repair of small sections of existing tile and the repair of tile blowouts discovered in the field at the time of construction.

The plans, specifications and bid forms are available for download on or after September 19, 2012, at no cost, in Adobe .pdf file form, on the website of the Sugar Grove Township Assessor's office. Anyone who will submit a bid must supply an e-mail address by emailing [rrdd2clerk@gmail.com](mailto:rrdd2clerk@gmail.com).

All proposals must be accompanied by a bid bond, certified or cashier's check, or a bank draft in an amount equal to at least 5% of the bid, payable without condition, to the Rob Roy Drainage District No. 2, which sum shall be forfeited in case the successful bidder fails to enter into a binding contract or provide a properly executed contract surety bond within ten days after the date the contract is awarded by the Board of Commissioners.

The successful bidder shall be required to furnish a satisfactory contract bond to the Rob Roy Drainage District No 2 by a surety company authorized to do business in the State of Illinois, covering the full amount of the contract. **The successful bidder shall pay prevailing wage and shall provide certified payrolls to the Rob Roy Drainage District No. 2 for the duration of the project.**

The bidder shall submit, if requested by the Engineer (Wills Burke Kelsey Associates, Ltd.), a list of qualified references for projects of similar size and scope of this project. Proposals withdrawn may not be resubmitted at the same letting. Each bidder shall satisfy the Rob Roy Drainage District No. 2 as to their ability, financially or otherwise, to carry out the work. The right is reserved to reject any or all bids, or to waive technicalities at any informality in any bid.
